ODS cannot provide transportation for high school students. They must either be driven into camp by someone else or drive in on their own. Once belongings are unloaded and cars are parked, students are not allowed to get back into vehicles until camp is over on Friday. High School Students must be in camp ready to begin training by 1:00 PM Saturday before the week they will counsel. They need to remain in camp until 4:15 PM Friday and must be picked up soon afterward. When you arrive to pick up a counselor please wait in the parking area and your high school student will find you there at 4:15pm.

Students need a "sack supper" for the Saturday evening meal. No other food or drink should be brought into camp!

MAJOR RULES:

1. **Outside of a doctor's care, there are absolutely NO drugs, alcohol, marijuana vaping items or tobacco allowed in camp.**
2. **High school students must each remain in his/her cabin area at night with the sixth graders.**
3. **Sixth grade students will NOT be harmed in any way by high school students.**

"I understand that should my son/daughter be found in violation of a major rule at camp, the high school administration and I will be notified, and my son/daughter will need to leave camp immediately. I give permission for my child to attend ODS as a counselor."
